Dennis Wiederkehr made a motion to add the pass through language that follows presented by Andrew Post to the bylaws, Al Wiederkehr 2nd, Motion Carried

Add to the by-laws; approval to pay pass through sign payments to the highway Dept for example: if a winery pays the council for the amount the highway dept charges to put up a sign then the council may bill the winery for the sign and approve the highway dept putting up the sign and subsequently paying the Hwy Dept. This type pass through transaction may be handled through the chair and the treasurer without board approval.
